#### V. PROGRAMMES ORGANIZED BY VARIOUS COMMITTEES

#### 1. ACADEMIC OUTREACH COMMITTEE

#### a. Inaugural Lecture of Nyaya Vichara

Academic Outreach Committee organized the Inaugural Lecture of Nyaya Vichara, the Annual Lecture Series of Christ Academy Institute of Law on 18<sup>th</sup> March 2025 at Christ Academy Auditorium from 10 AM to 12 PM. Hon'ble Mr. Justice Kurian Joseph, Former Judge of the Supreme Court of India has delivered the lecture on "Constitutional Values in the Contemporary Society". Nyaya Vichara, is aimed at fostering intellectual discourse and inspiring critical thinking among students by creating opportunities for them to interact with eminent personalities from various fields. Justice Kurian Joseph in his lecture reminded the importance of certain values of the Indian Constitution, which are the pillars of the Constitution and explained the challenges faced by these values in contemporary society. The role of various institutions, including the judiciary, to protect these constitutional values is also highlighted by Justice Kurian Joseph. The lecture was attended by the students of all semesters of BA/BBA/BCom LLB and faculty members of Christ Academy Institute of Law.

#### b. Workshop On Academic Legal Writing

Academic Outreach Committee of Christ Academy Institute of Law organised a Workshop on Academic Legal Writing for the undergraduate students of CAIL on 7th March, 2025 at 11.45 AM at St. Chavara Hall. An engaging Q&A session followed, where students actively participated, seeking clarity on various legal remedies and procedures. Session concluded with a vote of thanks, and feedback from attendees reflected that the workshop was highly informative and impactful.

This initiative reinforces the institution's dedication to creating a safe, inclusive, and gender-sensitive environment while equipping students with the knowledge to prevent harassment and discrimination.

#### 4. CENTRE FOR LAW AND ENVIRONMENT

The "Eco-Bag Revolution: Say No to Plastic" awareness campaign was conducted on 3rd & 4th April from 4 pm to 6 pm to the shopkeepers of Hullahalli and nearby premises. The objective was to educate shopkeepers about the importance of using paper bags and to spread awareness about the Plastic Waste Management Rules, 2016, along with other related regulations. During the session, Prof. Saumya shared her expertise and discussed the legal mechanisms for gender justice, challenges in implementation, and necessary reforms needed. The speaker differentiated gender justice from gender equality, explored women's subordination, and analyzed key gender-related terminology. She highlighted the role of statutory laws and gender perspectives in strengthening legal frameworks for greater inclusivity and fairness.

The session concluded with an interactive Q&A segment, allowing students to seek clarity on legal remedies and procedures, followed by a vote of thanks. Feedback from attendees indicated that the workshop was very informative and well-received, reinforcing the institution's commitment to fostering a safe and respectful learning environment.

## 8. CENTRE FOR PROMOTION OF KANNADA LEGAL LITERATURE AND SUSTAINABLE VILLAGES

Organized a special guest lecture at Chavara Hall on March 14, 2025. Students of the 2nd Semester, BA LLB, BBA LLB, and B.Com LLB attended the special lecture.

Guest speaker of the programme, Sri. Ka Ta Chikkanna, President of Santakavi Kanakadāsa Mattu Tatvapadakārara Adhyayana Kēndra, Bangalore, Government of Karnataka, has delivered an inspiring lecture on the Importance of translating Kannada Legal Literature, highlighting its significance in making legal knowledge accessible to all. The event featured speeches, a lamplighting ceremony, and an interactive Q&A. Faculty Convener Dr. Subramanya Swamy and Principal Rev. Fr. Davis Pandan addressed the gathering. Feedback from 220 students showed that 70%

rated sessions highly, appreciating their educational value and requesting more such events. The program concluded with a patriotic National Anthem.

The guest lecture was both enlightening and intellectually stimulating, providing deep insights into the significance of translating Kannada legal literature. It highlighted how such efforts play a crucial role in democratizing legal knowledge and making the law more accessible to all. The speaker's words also served as a source of inspiration for the students, encouraging them to engage more deeply with the subject.

#### 9. THE LEGAL SERVICES COMMITTEE

Organized a Legal Services Camp in Kadathipur, Doddaballapur, on March 21-22, 2025. With over 70 student volunteers, the camp tackled pressing issues such as that of water scarcity, lack of healthcare, child rights violations, and urban waste hazards. Hon'ble Judge Shri Ravi Betedaar inspired attendees as students bridged legal knowledge with real-world impact. Beyond textbooks, they gained practical advocacy skills, a deeper purpose, and the power to drive change-one case, one voice at a time.

Through legal aid, surveys, and cultural initiatives, the camp fostered social responsibility and grassroots advocacy, ensuring that law serves the people it protects. By stepping beyond textbooks and into the lives of the people, this camp was not just a learning experience, it was a powerful step towards accessible justice and meaningful legal service.

#### 10. CONSTITUTIONAL LAW COMMITTEE

Hosted its first-ever **Intra Model United Nations** on April 16, 2025. This pioneering event aimed at fostering diplomatic skills, critical thinking and global awareness among law students while providing a platform to debate contemporary international issues through structured committee simulations. The event's purpose is to cultivate negotiation abilities, public speaking confidence and research skills essential for legal professionals. Expected outcomes include enhanced understanding of global governance, strengthened student community and identification of talented delegates who may represent the institute at external MUN conferences.

#### 11. NATIONAL SERVICE SCHEME (NSS)

a. Swachh Bharat Abhiyan – was conducted on 28th February, 2025 in the nearby areas of Kempapura, Jigani Hobli, Bengaluru-South district. The event commenced at 11:00 AM and continued till 1:15PM. The event was flagged off in the presence of Dr. Sini John, Vice-Principal, CAIL, NSS Faculty members and volunteers. With an objective of raising awareness towards cleanliness of the surroundings and to support the national mission of creating a cleaner and

healthier environment, the event witnessed an active participation of around 43 students including NSS volunteers and members of the committee. Also, students of 4th Semester BA LLB (A) section participated in the event. The event was not only a practical step towards a cleaner environment but also an enriching experience for the students, reinforcing the values of community service, teamwork and responsibility towards surroundings.

**b. Plantation Drive** - The Plantation Drive, a crucial environmental initiative, aimed to combat deforestation and mitigate climate change by encouraging the widespread planting of trees. This initiative was carried out by NSS, CAIL on 7th March, 2025 wherein 10 NSS Student volunteers and 32 students of 6th semester BCOM LLB participated. The initiative aimed to raise awareness among students about the importance of plantation and its positive impact on the environment. The team, filled with enthusiastic volunteers, arrived at the plantation site in Mylasandra Village, Begur Post, Bengaluru Urban at 11:00 AM. They carried with them a total of 19 plants, each carefully chosen to thrive in the local environment. The team members, guided by the NSS coordinators, worked diligently to ensure each sapling was firmly planted in the soil, with special care taken to position them properly to allow for optimal growth.

The event started with a briefing session where the NSS coordinators explained the schedule, roles, responsibilities, and safety instructions. The NSS volunteers seized this opportunity to educate students on the critical importance of tree planting in combating climate change, enhancing biodiversity, and providing clean air. They explained how trees play a vital role in reducing air pollution, conserving soil, and supporting wildlife, instilling in students a sense of environmental responsibility

c. Blood Donation Camp - NSS organized a Blood Donation Camp on 21/03/2025 at Christ Academy Institute of Law in association with the Lions Club. The main objective of the camp was to promote the spirit of social responsibility among students and staff and encourage voluntary blood donation. The Lions Club members reached the campus by 8:00 AM. They efficiently set up the required arrangements, including medical equipment, blood collection units, seating areas for donors, and refreshment stalls. Sanitation and safety protocols were strictly followed to ensure a hygienic environment. The faculty and the NSS volunteers played a significant role in coordinating the event. The camp officially commenced at 9:00 AM and continued till 2:00 PM. Students were called semester-wise to maintain order and avoid overcrowding. Students of all the batches participated in the event. The donors were attended by trained doctors and nurses from the Lions Club. Each donor received a certificate of appreciation recognizing their valuable contribution. The camp witnessed enthusiastic participation from students across all batches. By the time the camp concluded at 2:00 PM, around 95 units of blood had been collected out of 110 registrations.

The event was well-organized, and no major health concerns were reported. The contribution made by the donors will undoubtedly help save many lives.

#### d. NSS Special Camp

A 3- Day Special Camp was conducted from 1st April to 3rd April, 2025 in Chintamani Taluk, Chikkaballapur District, Karnataka to inculcate in the students the spirit of social service and selfless contribution towards the society. The students were selected through a rigorous interview session on their interest and passion towards social service.

Several activities were planned for the camp and the students were given an orientation regarding the camp. During the three -days, the activities included Swachh Bharat activities, School Awareness Programme, Household Survey regarding awareness of the government schemes and Street-play on the issue of Domestic Violence. The NSS faculty members and the students showed enthusiasm towards the camp which successfully concluded on 3rd April, 2025. It encapsulated the spirit of service, learning, and unity.

#### e. School Awareness Programme

The NSS, CAIL organised a school awareness program on 11th April 2025 from 11:00 AM to 12:45 PM. The main motive of this event was to spread awareness among the children and teach them to proceed for the education and made them understand why education is important. So, with this positive initiative, the NSS team went to Sakalavara village of Bengaluru, Karnataka. **16th INTRA COLLEGE MOOT COURT COMPETITION, 2025** – was held on March 10, 2025. This competition organised by the Moot Court Committee, witnessed the participation of 183 teams. The competition focused on refining the advocacy skills of budding lawyers by offering them a platform to present and defend legal arguments effectively. The competition was judged by 20 distinguished faculty judges, who meticulously evaluated the participants on legal reasoning, presentation skills, and courtroom etiquette. The event's paramount aim is to foster the development of legal research, writing, and advocacy skills among law students as well as to simulate real-world court proceedings and provide participants with practical experience. The top scorers from the competition will represent CAIL in various national and international moot court competitions for the academic year 2024-25.

With yet another successful edition, the Intra Moot Court Competition has proven to be a vital part of legal education at Christ Academy Institute of Law. It motivates students to hone their advocacy skills and build a strong foundation for their future.

#### 14. HAPPINESS LAB

#### Felicitation program:

On January 3, 2025, St. Kuriakose Elias Chavara Award ceremony, along with Felicitation Ceremony was done by IQAC in Collaboration with Happiness lab. The program took place from 10:00 AM to 1:00 PM in Christ Academy Auditorium. The chief guest for the event was Mr. Jugnu Uberoi. The Audience for the ceremony were all semesters, parents and alumni invited for the same. Felicitation ceremony started after the completion of St Kuriakose Elias Chavara awards. The Felicitation Ceremony awarded students who scored above 65%, with trophies and medals.

#### Play Arena 2.1:

The Happiness Lab orchestrated the 'Play Arena' on 11th March 2025 inviting students across all batches and faculty members to engage in a jovial gathering at the 6th floor. #### 15. YOUTH RED CROSS COMMITTEE (YRCC)

a. A three-day special camp was organised at the Government Higher Primary School in Jalamangala, Ramanagara, Bangalore, from April 4th to April 6th, 2025. A total of 177 students, accompanied by five faculty members, participated in this camp. After reaching the campsite, the volunteers engaged in cleaning the classrooms and settling into their accommodations.

The evening was dedicated to poster-making sessions that addressed a variety of social and health issues, including initiatives for Clean Villages, Literacy Improvement, Disease Prevention, Menstrual Health, Constitutional Awareness, Nutrition, Child Marriage, Drug Awareness, the Protection of Children from Sexual Offences (POCSO) Act, and the POST Act. Subsequently, the volunteers were organized into groups and assigned specific topics for awareness presentations, which were scheduled for the following day. Preparations for both the presentations and a cultural program continued into the evening, culminating in dinner and a period of rest.

On the second day, seven student groups delivered structured awareness presentations to the higher primary school students, under the guidance of faculty members. Simultaneously, two survey teams, led by faculty, conducted field surveys in the village, focusing on issues such as Drug Usage, the POST Act, Constitutional Awareness, Disease Prevention, Literacy, and Cleanliness. The evening was highlighted by vibrant cultural performances presented by the volunteers.

The third day featured a community rally that showcased street plays and dramatic performances aimed at raising awareness of critical social and health issues.

Following the rally, the camp concluded with a valedictory ceremony held on-site. After lunch, the team departed from the venue and returned to the college campus.

b. Workshop titled "Taking Care of Vulnerable People: Moving Together – Imagining Inclusive Transport for Older Adults in Urban India" was conducted on April 25, 2025, led by Dr. Prajwal Nagesh, a sociologist.

The workshop emphasized the need for inclusive urban transportation for older adults, providing participants with insights into the physical, mental, and emotional changes that come with aging. #### VIII. UPDATES ON THE THRUST FOR THE ACADEMIC YEAR 2024-25

#### CHRYSALIS - ACCOMPANIMENT OF A STUDENT IN THEIR STRUGGLES.

The *Chrysalis* initiative was introduced at CAIL and based on the recommendations of **Hon'ble Justice Kumar** and **Dr. Sairam Bhat**, the specific objective of supporting students who have lost the primary breadwinner of their families with scholarships apart from the regular scholarships was considered.

Following this, a circular was circulated among the students and **five students** have submitted applications for support under this initiative. A team comprising CAIL faculty members and peer student volunteers is currently coordinating visits to the homes of these students to assess their needs and extend the necessary support.

#### 2. COURT VISIT

It is mandatory for every student from Semester I to Semester X to undertake one visit to a trial court and one visit to a constitutional court each semester and attend the court proceedings.

To facilitate this process, a **special orientation session** has been conducted by the faculty, and a structured **Court Visit Diary** has been designed for student use. Upon completion of the Court Visit the Student must collect a signature with the office seal of the Advocate towards the last page of the Court visit Diary. (1) Case Number including the filing date (2) Stage of the Case (3) Details of the Parties (4) Facts in Brief (5) Arguments Advanced not exceeding 5 pages of report shall be included in the Diary. The student shall write a judgment based on the observed case.

#### 3. Special camps for NSS, Legal Aid and YRCC - Village Exposure

As part of the Village Sustainability Development Programme, the NSS, Legal Aid, and Youth Red Cross Committees, each committee organized **two special camps** during this academic year. Every student was required to participate in any one of these camps during the year. **Total of 438 students out of 658 students** participated in the camps.

#### 4. Legal Literacy Promotion - Nyaya Shraddha

An initiative introduced with the objective of empowering the general public through legal awareness and outreach. As part of this initiative, each class was expected to organize a class-wise program aimed at addressing relevant legal issues and engaging with the community. To encourage participation and excellence, the best class program is recognized and rewarded. During the current semester, 25 classes successfully organized programs under this initiative in the Odd Semester in the AY 2024-25 and the efforts will be continued and expanded in the upcoming semesters.

#### 5. Committee Posters

To raise awareness about the aims and objectives of the committees at CAIL, each committee designed 4 posters highlighting the significance of their committee. #### 6. Mentorship Program

The **Mentorship Program** at CAIL, an integral component of the academic curriculum, has been further strengthened to enhance student support and engagement. Each student is required to complete a **minimum of three mentorship hours per semester**, during which they must meet with their assigned mentors. In addition to these scheduled interactions, mentors proactively reach out to parents in cases concerning **attendance**, **academic performance**, **or notable achievements**, ensuring consistent communication and collaboration between the institution and families.

#### 7. Parent Teachers Meeting

To promote active parental involvement in the holistic development of students, CAIL conducts online PTM every semester. From this semester online PTMs are scheduled during the Odd Semester, while offline PTMs are made mandatory during the Even Semester.

This semester, the **offline PTM for students from 1**<sup>st</sup> **to 4**<sup>th</sup> **year** will be held on **10**<sup>th</sup> **May**, and for **10**<sup>th</sup> **semester students**, it will be conducted on **28**<sup>th</sup> **May**.

#### 8. Internship

The internship committee is closely monitoring the internship taken up by our students by collecting the geo-tagged pictures, certified internship diaries and certificate signed by the interning organisation. Next semester onwards we will be in a position to allot 21 days mandatory internship during the academic calendar as per the KSLU guidelines.

#### 9. Unnat Bharat Abhiyan (UBA)

Ministry of Education (MoE), Government of India has launched a flagship Program at National level called Unnat Bharat Abhiyan (UBA), with the vision to involve professional and higher educational institutions in the development process of rural areas in the country to achieve sustainable development and better quality of life and experiential learning among students.
