AWARDS & RECOGNITIONS FOR STUDENTS

To encourage the outstanding students in academics, co-curricular and extra-curricular activities, CAIL provides various awards, as detailed below.

Provides Best Intern Award (**Trophy & Certificate**) for 6th, 7th, 8th and 9th Semester students to appreciate the efforts put in by the students, to get the best internships and for their exceptional work during the Internship period.

9. BEST PAPER AWARD

With regard to the Assignment for the students for the upcoming semester, BEST Paper for each subject will be awarded with **Rs. 1000/-**, and if the paper is published in any reputed journals, the student will be rewarded with additional **Rs. 2000/-**.

10. CASH AWARD FOR ARTICLE PUBLICATION

Cash Award of **Rs.500/-** for students who publish papers/articles in ISBN / ISSN Journals.

SCHOLARSHIP FOR STUDENTS

To encourage the meritorious students, CAIL provides internal scholarships based on their performance in the KSLU end semester examinations.

I. STUDENTS BELONG TO GENERAL CATEGORY

1. Scholarships for General Category Students

- Students who have secured **80% and above marks** in the semester examinations: Full tuition fees waiver for the semester (i.e. 50% of your yearly tuition fee).

- Those who have secured **75% and above marks** in the semester examinations: 50% of tuition fees for the semester (i.e. 25% of your yearly tuition fee).

2. Cash Awards for Overall Toppers and Subject-wise Toppers

- **1st, 2nd and 3rd Rank** – Students must attain an aggregate of **70% Marks and above** in the KSLU end semester examination, attain an aggregate of 70% attendance and pass in First Attempt in that particular semester. Also, they should not have any backlogs (Backlogs of the previous semesters, if any, should be cleared).
- **Subject-wise Toppers** – Students must attain an aggregate of 70% attendance and pass in the first attempt, and should secure 70% and above marks in the respective subject. Also, they should not have any backlogs (Backlogs of the previous semesters, if any, should be cleared).

II. Students Hailing from Karnataka Villages

- Students who have secured 75% and above marks in semester examinations - Full tuition fee waiver for the semester (i.e. 50% of your yearly tuition fee).
- Those who have secured 70% and above mark in the semester examinations: 50% of tuition fees for the semester (i.e. 25% of your yearly tuition fee).

III. STUDENTS BELONG TO CHRISTIAN MINORITY

- Students who have secured 75% and above marks in semester examinations - Full tuition fee waiver for the semester (i.e. 50% of your yearly tuition fee).
- Those who have secured 70% mark and above in the semester examinations: 50% of tuition fees for the semester (i.e. 25% of your yearly tuition fee).

IV. STUDENTS BELONG TO SC/ST CATEGORY

To provide financial support and to encourage the meritorious students, who belong to **SC/ST Category**, CAIL provides the following scholarships/awards, from the academic year 2024-25.

1. One-time Concession during Admission to 1st Year

- Rs.10,000/- concession in the 1st year academic fees will be granted to students who belong to **SC/ST category**, during admission to 1st year (only).

2. Scholarships for SC/ST Students

- **SC/ST Students** who have secured **70% and above marks** in the Semester Examinations, attain an aggregate of 70% attendance and pass in the First Attempt in that particular semester: Full tuition fees waiver for the semester (i.e., 50% of the yearly tuition fee).
- **SC/ST Students** who have secured **65% and above marks** in the Semester Examinations, attain an aggregate of 70% attendance and pass in the First Attempt in that particular semester: 50% tuition fees waiver for the semester (i.e., 25% of the yearly tuition fee).

In the above 2 cases, if the student has secured above 80% or 75% respectively, and is eligible for scholarship as per the general category, the scholarship will be considered only one time.

3. Cash Awards for Overall Toppers and Subject-wise Toppers

- **1st, 2nd and 3rd Rank:** Students, who belong to **SC/ST category**, must attain an aggregate of **60% Marks and above** in the KSLU end semester examination, attain an aggregate of 70% attendance and pass in the First Attempt in that particular semester. However, they should not have any back logs (Back logs of the previous semesters, if any, should be cleared).

Note: If the student has secured 70% and above marks and is eligible for scholarship as per the General Category, the scholarship will be considered only one time.

- **Subject-wise Toppers:** Students must attain an aggregate of 70% attendance and passed in the first attempt, and should secure 70% and above marks in the respective subject. Also, they should not have any back logs (Back logs of the previous semesters, if any, should be cleared).

In the event of a tie for the highest marks, other criteria such as aggregate marks and attendance will be considered to determine the topper.

HEALTHCARE SERVICES

- Nursing assistance and first aid facility is available at Health Room during the college hours to support the physical well-being of students.
- We will be implementing health insurance plan to all the students of CAIL from the academic year 2024-25 to provide students with added security and support in case of any medical needs.
